Key points

Foster care in Scotland

- The number of foster care households in Scotland continued to decrease.
 - At 31 December 2022, there were 3,261 approved foster care households down 4.8% from 3,426 in 2021.
 - The proportion of households approved for all placement types (60%) was higher than the four preceding years.
 - There were fewer new households approved (194) than in any of the four preceding years.
 - o In 2022, 402 foster care households deregistered.

The number of children and young people in foster care continued to decrease.

- At 31 December 2022, there were 4,162 children and young people using fostering services. The number of children and young people using fostering services has decreased each year over the last 4 years, down from 5,171 in 2018.
- As with previous years, there were more children placed in interim placements (1,845) compared to permanent (1,178) or long-term (1,115).
- o 334 children experienced an unplanned ending of their placement in 2022.
- There were 99 children seeking asylum and refuge using fostering services in 2022, the highest number recorded to date.

• Not all family groups of children are placed together.

- In 2022, similar to each of the previous four years, 24% of the family groups placed in foster care households were placed separately (some following assessment, others due to emergency situations and lack of resource).
- 70% of services said they had difficulties in 2022 recruiting households that will take family groups of children.

• In 2022, 49 fostering services said they have a continuing care service.

 In 2022, there were in total 428 approved continuing care households and 434 young people accommodated in a continuing care placement.

Adoption in Scotland

- The number of children and young people approved for adoption increased.
 - o In 2022, there were 240 children approved for adoption, 31 more than the previous year.
 - 181 children were placed with their new adoptive families (down on the previous year) and 193 children were legally adopted (similar to the previous year).
- The age profile of children approved for adoption returned to the pre-2021 trend.
 - In 2022, 45% of children approved for adoption were in the two to five age bracket and 49% were infants. In the preceding year, there were more two- to five-year-olds approved than infants (49% and 45% respectively).
- Fewer adoptions broke down in 2022 than in the previous year.
 - o In 2022, 12 adoptions broke down compared to 37 in 2021.
- In 2022, there was a levelling off in the number of adoptive households approved since a gradual decline from 2018.
 - There were 236 new adoptive households approved in 2022, 32 less than in 2021.
 - A higher proportion of new households (25%) were approved to adopt children aged six years or older than previously (11-13%)
- The number of households waiting for a child to be placed was higher in 2022 than in each of the four preceding years.
 - o In 2022, 236 households were waiting for a child to be placed.
 - At the same time, there were 135 children approved for adoption and waiting to be matched to an adoptive household (similar to the previous year and less than in each of the years 2018-2020).

Introduction

All children need strong supports and steady, caring relationships to thrive. Fostering and adoption are two vital parts of the flexible scaffold of support that can help children build happy and healthy lives. This report provides insight into the operation of fostering, adoption and continuing care services in Scotland over the past five years. At 31 December 2022, there were just under 11,500 care services registered with the Care Inspectorate, including 38 adoption and 58 fostering services provided by the local authority and the voluntary/not-for-profit sector.

All of us have a role in helping children in Scotland thrive. We hope that the insights in this report can play a part in improving and strengthening the supports which are in place for children and young people through adoption, fostering and continuing care services. We would like to especially thank the providers of these services who invest significant time in providing information to us each year. By working together, we can stand up for children and strengthen communities across Scotland.

Background

Foster care and adoption services are vital for assessing, approving and supporting foster carers and the recruitment and assessment of prospective adoptive parents to care for children at a crucial point in their lives. All children need high-quality care that addresses their emotional and wellbeing needs. Matching children to families who can provide high quality care is essential to help children thrive. Ongoing assessment and planning are crucial to make sure children are being looked after in families, either their own or in alternative family settings, that address their best interests throughout childhood. Where permanency is required, planning for a placement should not be delayed. This is so that children have the best opportunity to make new attachments within their foster or adoptive family where they can start to feel secure and cared for.

Local authorities have a legal responsibility for ensuring that children in need of foster care and adoption are safe, loved and part of a family that can meet their needs and nurture them to thrive. Local authorities in Scotland are legally required to provide fostering and adoption services within their authority areas. They can also work with voluntary/not-for-profit fostering and adoption services to place children with carers where that is in the child's interest.

This report is based on data collected by us from service providers in their annual returns over the last five years from 2018 to 2022. The most recent annual return data covers the period 1 January 2022 to 31 December 2022. This report also includes our evaluations of service quality, correct at 31 March 2023.

Over the summer of 2015, we worked with colleagues in the Scottish Government, service providers and their representative bodies to review the content of our annual returns. This work has enabled us to collate a meaningful summary of adoption and fostering statistics across Scotland. This is the seventh in the series of adoption and fostering statistical bulletins; all of which can be accessed here.

We added some questions to the 2018 fostering annual return about continuing care for young people aged 16 to 21 years following the enactment of part 11 of the Children

and Young People (Scotland) Act 2014, Continuing Care.¹ For the first time, last year we included a summary of the continuing care data for the years 2019, 2020 and 2021, which will be continued this year. Please regard these statistics as estimates and let us know what you think of them by answering our <u>short feedback survey</u>.

In this latest bulletin we have applied a Promise lens and worked with the Each and Every Child initiative to help us to align our language and help keep the Promise. For ease of writing, throughout this bulletin 'children and young people' is often shortened to 'children'.

For the purposes of this publication, family group has the same definition as sibling in that it encompasses children who are brother and sister or have a brother- or sister-like relationship with each other.

Notes on the data used in this report

Data quality

Most of the data in this report was provided directly by service providers in their annual returns to the Care Inspectorate. As data is self-reported by services, there may be small discrepancies in the data provided. In this publication, to accurately reflect trends over time and to allow year-on-year comparisons to be made, where a service has not completed an annual return, we impute data from information provided by the service from their last submitted return. We also investigate outliers in the data and validate or modify them as appropriate.

All bar one of the 38 registered adoption services and all the 58 registered fostering services submitted their 2022 annual return. It is expected that the Covid-19 pandemic will have had an impact on trends in this data from 2020 to 2022. We have not attempted to quantify the extent to which the pandemic may have disrupted the trends in this report although we have footnoted the tables and charts that we expect might have been affected.

We have excluded one adoption service and two fostering services from the statistics that follow (except from our quality evaluations). This is because they are not involved in the approval of households or children for adoption or fostering and therefore many of the aspects we present in this report do not apply to them.

Grading

During 2021, we introduced some changes to how we evaluate services that will have an impact on the grading data in this report.

¹ Continuing care is the continued provision of accommodation and other assistance that is being provided immediately before a young person ceases to be looked after until their 21st birthday. Only children who cease to be looked after aged 16 years or over and were looked after away from home are eligible for continuing care.

In May 2021, we introduced a new quality framework, details of which can be found in the document A quality framework for fostering, adoption and adult placement services.

The quality framework is framed around key questions and will be used by inspectors in place of the older approach of inspecting against quality themes and statements. Up until May 2021, we evaluated fostering and adoption services across three quality themes – care and support, staffing, and management and leadership. Information on these evaluation criteria can be found in the document How we inspect. Where a service has not yet been inspected under the new quality framework the corresponding grade from the previous quality theme methodology will be used instead.

Other related sources of statistics

The data published in this report is consistent with figures published in the Scottish Government's <u>Children's Social Work Statistics 2021-22</u>. The slight differences in numbers are due to different reporting periods, and differences in how the data is gathered and cleaned.

This bulletin does not report any complaint statistics as these are included in our annual complaints statistics bulletin 'Complaints about care services in Scotland', which can be found on the Care Inspectorate <u>statistics webpage</u>.

Section 1: Foster care

Fostering services

At 31 December 2022, there were 58 fostering services in Scotland registered with the Care Inspectorate, made up of 32 local authority services and 26 voluntary/not-for-profit organisations (referred to as independent services in the statistics that follow). There were no new fostering services registered in 2022, however there was one independent service that cancelled.

All fostering services submitted a 2022 annual return.

We have excluded two fostering services from the statistics that follow (except from our quality evaluations). This is because they are not involved in the approval of households or children for fostering and therefore many of the aspects we present in this report do not apply to them.

The 2022 data presented in this report is therefore based on the data reported by 56 fostering services in their annual returns, together with evaluation data as at 31 March 2022 for all 58 fostering services.

This report covers five different aspects of fostering services:

- foster care households
- children and young people with care experience
- fostering service capacity
- continuing care
- fostering service evaluation.

Foster care households


Figure 1.1 Number of approved foster care households¹ at 31 December, with sector split.

At 31 December 2022, the 56 fostering services in Scotland had a combined total of 3,261 approved foster care households² (Figure 1.1). Similar to previous years, 67% of approved households were registered with local authority services and 33% were with independent services.

Figure 1.1 and Figure 1.2 show that overall and in each sector the number of approved foster care households is decreasing over time, more so in the local authority sector.

At the service level, 15 services had more foster care households in 2022 compared to the previous year, however 33 services had fewer households, resulting in the overall decrease of 165 households (4.8%) since 2021.

² This may be subject to some double counting. Regulations allow a foster carer to be 'registered' with more than one agency, however this is intended as an enabling provision in certain circumstances not one which should be regularly used (<u>Guidance on the Looked After Children (Scotland) Regulations 2009 and the Adoption and Children (Scotland) Act 2007 – Chapter 11 The Assessment and Approval of Foster Carers).</u>

Figure 1.3 and Figure 1.4 present the number of approved households split by their approval type, over time. Across all services the most common placement approvals are for all types of placements and interim only (at 60% and 19% respectively). In local authority services the most common placement approval continues to be for all types of placements and interim only (at 50% and 27% respectively).

In local authority services, the number and proportion of approved households with approval for all placement types decreased year on year, apart from in 2019 and 2022 where there was an increase, alongside a decrease in permanent only, long-term only and interim only. In 2020 and 2021, the proportion of households approved for all types of placements fell considerably, alongside an increase for interim only placements in 2020 and permanent only and long term only in 2021.

In independent services, in each of the years 2018-2022, the majority (at least 69%) of households were approved to provide all types of placements. Permanent only placement type approval has consistently been the second most common approval type in independent services.



At 31 December 2022 (Figure 1.5), there were 398 households approved to provide short breaks only, lower than the four previous years and down 8% from 434 in 2021. This decrease is mainly driven by a decrease reported by one service.

Of the 3,261 approved households (Figure 1.1), 589 (18%) had approval to care for children of any age (Figure 1.6). This is down from 707 (21%) in 2021 and is the lowest number over the five-year period, although not the lowest proportion and there is year to year variation.

Private fostering

Private fostering is an arrangement where a parent makes an agreement with someone who is not a close relative of the child to care for that child for more than 28 days. These arrangements are not facilitated by the local authority or a registered service. It is very possible that private foster carers will not be aware of their responsibility to notify

the local authority of these arrangements or that local authorities do not recognise these arrangements as private fostering. Therefore, it is likely that there are more private fostering arrangements taking place than we and local authorities are being notified of.

There were thirteen notifications of private fostering in 2022, eleven in 2021, five in 2020 and six in each of 2019 and 2018.

Recruitment and de-registration


Over the course of 2022, there were 194 new foster care households approved (see Figure 1.7 and Figure 1.8). There has been a downward trend in the number of new foster carers approved over the past 5 years which has accelerated in the last year.

Sixty per cent of the new households were approved by local authority services and 40% approved by independent services, with both sectors showing an overall downward trend over time.

Services varied in their recruitment success, with the number of new households ranging from 1 to 10 at the service level. Nine fostering services did not approve any new households in 2022.

Figure 1.7 the number of new foster carers approved each year has fallen in each of the last four years.

New foster care households approved between 1 January and 31 December, with sector split.



Guidance on the Looked After Children (Scotland) Regulations 2009 and the Adoption and Children (Scotland) Act 2007 states that authorities should normally aim to complete an assessment within six months of receiving an application. Therefore, the length of the assessment should be measured as the time between when the application was received and approval by the agency decision maker. This is not defined in the annual return (although we will aim to address this) therefore there may be an inconsistency across services in how assessment time is calculated.

In 2022, 59% of the overall number of new foster carer assessments were completed within six months, which is lower than the previous year (see Figure 1.8). Just over a quarter (26%) were completed between six months and a year. A smaller amount (30 assessments, 15%) took a year or more to complete which is greater than the previous year.

Over the past five years, there was a drop in the total number of new foster care households approved, together with an increase in both the percentage and number of assessments completed at 12 months or more. However, the percentage and number of assessments completed within the target six-month period is lower in 2022 than the previous year for both independent and local authority services.

The number of new households that are approved may include a small amount of double counting at the national level, owing to the rare situation where households are registered with more than one fostering service.

Recruiting households that would foster family groups (Figure 1.9) was a challenge for 39 fostering services (70% of all services) in 2022. This is the same as the previous year, and has been increasing in the last five years, particularly for independent providers.

As in previous years, the main reason for this was accommodation constraints (services told us this was due to factors such as housing size, deprivation and local demographics). Difficulty recruiting households in a restricted market; the increased demand on placements arising from continuing care; and the impact of the Covid-19 pandemic, were also cited as reasons.

Over the course of 2022, 402 foster care households deregistered from their fostering service (Figure 1.10), a similar amount to the previous year. Since 2018, the number of households de-registering from local authority fostering services has fluctuated each year, but overall has increased, while in independent services the number has overall decreased.

Comparing the number of households that deregistered with the number of new households gives a net change for each year and Figure 1.10 shows the percentage of services that have experienced a net loss in households each year. The calculation of net change doesn't always match the change in carers from previous years data as it is composed of three independent measures that are self-reported by services. At an individual service level, we estimate that 36 fostering services – 64% of all services that recruit and approve foster carers – experienced a net loss in foster care households in 2022 – this is a slight increase on the previous year.

The number of households that de-register may include a small amount of double counting at the national level, owing to the rare situation where households are registered with more than one fostering service.

In 2022, up to 30 June, fostering services across Scotland received approximately 5,056 enquiries from potential foster carers (Figure 1.11). Of these, 4% led to applications, 37% of which were approved.

Over the five-year period, the number of enquiries has increased overall but the numbers of applications and approvals have fallen. Correspondingly, the percentage of enquiries that progress to applications and the percentage of applications that result in approvals have both fallen since 2018.

Children and young people with care experience


The Children (Scotland) Act 1995 and Adoption and Children (Scotland) Act 2007 places a duty on local authorities to provide fostering and adoption services. They are responsible for assessing and planning for children who, as an outcome of this assessment, require alternative care either through voluntary arrangements or compulsory measures of care. Local authorities, through service level agreements with independent fostering and adoption services, may place children with carers through these services. Independent fostering and adoption services also recruit, assess, and provide training and support to carers to ensure that they are providing a high-quality service to children and young people. When children are placed with an independent agency, it remains the responsibility of the local authority to support the child and to review the arrangement to ensure that it continues to meet the child's needs. Where permanency is required, this may be provided through a permanent foster placement or through adoption.

Placements

In 2022, there were 4,162 children and young people using fostering services (in a placement with an approved foster care household) (Figure 1.12 and Figure 1.13).

Of the 4,162 children using fostering services, 67% (2,786) were in local authority approved households and 33% (1,376) were in households approved by independent services.

The number of children using fostering services in 2022 was 194 fewer than the previous year, continuing the overall downward trend. This is mainly due to the number of children in foster care provided by the local authority decreasing each year, with the number of children in independent foster care households decreasing to a lesser extent.

²The decreasing trend may have been compounded by the Covid-19 pandemic.

The overall trend is consistent with figures published in the <u>Scottish Government's</u> <u>Children's Social Work Statistics 2021-22</u>, which also show a decrease over time in the number of children in a foster care setting.

Figure 1.14 shows that the number of children placed by local authority services has overall been slightly decreasing in permanent placements (27% in 2022) and increasing in interim placements (51% in 2022), while long-term placements has been similar over the five-year period (21% in 2022).

The number of children placed by independent services has a different pattern where overall permanent placements have been similar over the five-year period (30% in 2022), while long term placements have been increasing (39% in 2022) and interim placements have been decreasing (30% in 2022).

Like 2021, long term placements were the most common type for independent services in 2022, however, it should be noted this is mainly driven by less than five independent services. Excluding these services, there is a more even split between long term and permanent placements which is relatively stable over the previous five years.



Children and young people awaiting permanent placement

At 31 December 2022, there were 158 children and young people identified as needing a permanent placement who were not already in or moving towards such a placement (Figure 1.16).

While the number fluctuates from year to year, relatively speaking the overall proportion of children using fostering services and not in a permanent placement is similar each year, ranging from 5% to 7%.

At the same time, there were 20 children, across six local authority services who were living at home or with kinship carers and waiting on a foster care placement to become available.

Placements ending on an unplanned basis

Figure 1.17 shows that 347 placements involving 334 children and young people ended on an unplanned³ basis throughout 2022. This is similar to the previous year. Of the placements that ended, 59 (17%) were permanent placements – again, similar to the previous year.

There is a downward trend in the number of placements in households approved by local authorities ending on an unplanned basis.

Local authority commissioned placements

In 2022, 370 children were placed in a foster care placement purchased by a local authority (Figure 1.18) and this number has decreased by 24% over the last five years

from 490 in 2018. Most of the places (84%) were purchased through the national contract; 15% were exclusively short breaks which is notably higher than in any of the previous four years.

Children seeking asylum and refuge

There are children and young people placed in care services who have come to Scotland without the support of an adult and have the status of being children seeking asylum and refuge.

In 2022, 24 fostering services placed children seeking asylum and refuge, and this number has increased over the last five years (Figure 1.19).

There were 99 children seeking asylum and refuge using fostering services at 31 December 2022 (Figure 1.20). The number has increased over the past five years, more than doubling in the last year.

In 2022, the number of children coming into foster care exceeded the number of new foster care households in 29 of the 32 local authority services (Figure 1.21).

In situations where the number of children exceeds the number of available foster care households, local authority services may commission places with other fostering services. Where this is not feasible or possible, the local authority services may approve placements with their own foster care households that result in the household exceeding their approval range.

Figure 1.22 shows that throughout 2022, households exceeded their approval range on 693 occasions across 31 local authority fostering services and 11 independent fostering services.

As with previous years, where foster care households exceeded their approval range, it was for a variety of reasons, mainly to keep children from the same family together and to facilitate respite placements. Other common reasons included: to enable child/young person to remain close to their home community and school; to enable existing placements to continue beyond age approval; to make the most appropriate match between child/young person and their foster carer.

We expect that the lower numbers in 2020 and 2021 reflect the Covid-19 related easing of restrictions on approval range. This ties in with there being fewer commissioned places in 2020 and 2021 (Figure 1.18).

The Scottish Government laid in Parliament an amendment to The Looked after Children (Scotland) Regulations to introduce a maximum foster care placement limit of three unrelated children, with exemptions for family groups and emergency placements. The amended Regulations came into force on 29 December 2014.

To ensure compliance with this standard, the Final Report of the Scottish Government's Foster Carer Review recommends that all exemptions from the maximum limit that are granted by fostering panels, and all emergency placements made above the maximum limited, be recorded in the annual return. The information was first gathered in the 2018 annual return (Figure 1.23).

In 2022, across 19 fostering services there were 81 placements above the maximum limit of three unrelated children.


Family groups

At 31 December 2022, there were 927 family groups of children in foster care (down 11% from 1,042 in 2018) (Figure 1.25).

When placed in foster care households in 2022, 226 of the family groups (24%) were placed separately and 701 (76% of all family groups) were placed together.

Fostering service evaluation (grading)

Based on Care Inspectorate evaluations, the overall quality of fostering services on 31 March 2023 was positive. As Figure 1.27 presents, 83% of fostering services had evaluations of 'good' or better across all key questions (see Grading notes in Background section of document for further detail on inspection framework).

Between 1 April 22 and 31 March 23 we inspected 21 fostering services. Of those 21 services 71% (15) had evaluations of good or better across all key questions at 31 March 2023.

Continuing Care

Since 2018, we have been collecting data about continuing care for young people over the age of 15 and under 26 years following the enactment of the Children and Young People (Scotland) Act 2014, Part 11 Continuing Care.

Similar to last year, we are presenting the data for continuing care since 2019 (the 2018 data is not included for data quality reasons). Please regard it as an estimate.

In the 2022 annual return 49 fostering services said they had a continuing care service linked to them (Figure 1.28).

Fostering summary

Each year, there has been a decrease in the number of approved foster care households in Scotland. Coupled with this is a decrease in the number of households approved for short breaks. Between the years 2018 and 2022 the number of approved foster care households dropped by almost 500, from 3,758 to 3,261. This is because each year, more households deregistered than were approved. For example, in 2022, 402 households deregistered from a fostering service and less than half that amount of new foster care households were approved (194). Of the new households that were approved, 59% were assessed and approved within six months, whilst 15% of cases took over a year to complete. Longer approval times correspond to lower numbers of new approved households and may contribute to the decrease in foster carer numbers.

Of those households that are approved to provide foster care, there was an increase in the proportion approved for all placement types this year. This approval model might help to widen the pool of appropriate placement types. Matching children to the right foster carer household is important to ensure safe situations for children, positive outcomes and reduced risk of unplanned endings.

In 2022, 347 foster care placements ended on an unplanned basis, a similar number to the previous two years and down on the years 2018-2019 (although relatively speaking the proportion of unplanned endings hasn't changed over the past few years). Unplanned endings can mean multiple placement moves for children and disrupted relationships, which is known to have a considerable negative impact on children's attachments and development.

In 2022, 4,162 children were in a foster care placement in Scotland, down from the previous year and continuing the decreasing trend. Overall, the most common placement type in 2022 was interim placement. This has been the case for the past few years particularly in local authority placements, however the pattern has changed slightly for independent placements. In 2018, almost half of all independent placements were interim. Since then, the number of interim placements used by independent services has fallen coupled with an increase in the number of long-term placements being used. In 2018, long-term placements accounted for 22% of children using independent services compared to 39% in 2022. Long-term placements are ones that

can be in place for longer than 24 months and not secured by a permanence order, and they should be used only in exceptional situations.

Services should aim to move children into permanent placements without delay once it has been identified that is what is in the best interest of the child. Services reported that in 2022, 158 children (1 in every 20 children in non-permanent foster care placements) were not in or moving towards permanent placement despite it being in their care plan. Delay in achieving legal permanence compromises children's opportunities to experience stable, loving families throughout their childhood.

Children are more likely to settle and progress well if they are kept with their brothers and sisters, and of the 927 family groups of children placed in foster care in 2022, 76% were placed together. Part of The Promise 2021-2024 plan is to stop the practice of separating brothers and sisters, unless for reasons of safety. However, each year from 2018 to 2022, consistently around a quarter of family groups were placed separately and the main reason reported by services is lack of resource. Seventy per cent of services had difficulties in 2022 recruiting households that will take family groups of children and existing households exceeded their approval range throughout 2022 to keep children from the same family together. More independent services have reported difficulties in recent years: the proportion of independent services reporting difficulties has increased from 31% of services in 2018 to 58% in 2022.

This is the second year we have reported on continuing care and the data shows that in 2022, more young people were using continuing care (434 young people) and more households were registered as continuing care households (428) than in each of the three years previous. It also shows that of the young people leaving continuing care as part of a planned ending, 83% (179 of 216 young people) were in education, training or employment. This proportion is higher than in each of the three preceding years. All children and young people have the right to education and should receive all they need to thrive at school (The Promise, Plan 2021-2024).

Despite the challenges faced by fostering services, particularly around staff shortages (see <u>Staff vacancies in care services 2021</u> report) they continue to achieve positive evaluations from us during inspection. This bulletin reports on the published inspection evaluations at the 31 March 2023 with 83% of services achieving 'good' or better across all assessed key questions. Published inspection reports can be found on the Care Inspectorate website.

Section 2: Adoption

Adoption services

At 31 December 2022, there were 38 registered adoption services in Scotland; 32 were local authority services and six were voluntary/not-for-profit organisations (referred to as independent services in this report).

All except one adoption service submitted their 2022 annual return. For this service, we have imputed data from their most recent annual return.

We have excluded one adoption service from the statistics that follow (except from our quality evaluations). This is because they are not involved in the approval of households or children for adoption and therefore many of the aspects we present in this report do not apply to them.

The 2022 data in this report is therefore based on the data reported by 37 adoption services in their annual return together with evaluation data as at 31 March 2023 for all 38 adoption services. It is expected that the Covid-19 pandemic will have had an impact on trends in this data from 2020 to 2022.

This report covers four different aspects of adoption services:


- new approved households
- children and young people
- other services
- adoption service evaluation.

New approved households

Since 2018, there has been a downward trend in the number of new households being approved for adoption each year, with 2021 being above trend levels at 268 (across 37 adoption services). In 2022, this returned to 2020 levels with 236 new adoptive households approved across 37 adoption services (Figure 2.1).

Figure 2.1 the number of new households being approved for adoption has fluctuated in recent years, following the downward trend between 2018 and 2020.

Timescales to approval

The approval completion time for new households increased each year since 2020 with 76% of cases taking longer than six months to complete in 2022, compared to 66% in 2021 and 56% in 2020. (Figure 2.2). The way 'timescales to approval' is recorded in the annual return changed in 2020, therefore in previous reports, Figure 2.2 presented the number of services as opposed to the proportion of new approved adoptive households.

Age group approval

In 2022, just under two-thirds of the new households (60%) were approved to adopt children aged two to five years old; 39% were approved to adopt infants under two years old and 25% were approved to adopt children aged six plus (Figure 2.3). These proportions are similar to previous years with the exception of those approved to adopt over six years old, which is notably higher in 2022 than any of the previous four years. However, the number and proportion of households approved to adopt infants has overall been decreasing since 2018.

Values with fewer than five observations have been removed and replaced with '<5' and '<1%' and have been removed from the total number and percentage.

Households waiting

At 31 December 2022, 236 approved households across 29 of the 32 local authority services and in all five of the independent services were waiting for children to be placed. This is higher than the previous four years.

Recruitment

In 2022, an estimated 1,089 enquiries from potential adopters were received across all adoption services between 1 January and 30 June (Figure 2.6). Of these, 9% progressed to applications, of which 17% were approved by 31 December 2022. Note that some of the enquiries and applications may have been progressed after the 31 December and will not be included in these figures. Overall, a higher volume of enquiries and applications were received this year compared with previous years, but there was a notable drop in the number and proportion of approvals (as a percentage of applications) in 2022 compared to previous years.


Children and young people approved for adoption

The Children (Scotland) Act 1995 and the Adoption and Children (Scotland) Act 2007 places a duty on local authorities to provide an adoption service. They are responsible for assessing and planning for children who require alternative permanent care. Local authorities may, after following robust legal and matching processes, place children with adopters approved by them or by independent adoption services. Local authority and independent adoption services recruit, assess and provide training and support to prospective adopters to ensure that they can meet the needs and provide high-quality care to children.

In 2022, there were 240 children approved for adoption (across 27 local authority adoption services), up from 209 in 2021 and from 225 in 2020, but a decrease of 25% over the five-year period (Figure 2.7).

Figure 2.7 The number of children and young people approved for adoption has increased over the last year counter to the downward trend over the preceding four years.

The downward trend from 2018 to 2020 presented in Figure 2.7 is a consequence of decreases in the number of children and young people approved for adoption across many adoption services, however latterly, in 2021, the decrease was driven by just a few of the larger adoption services, whilst the others reported more or the same number as the previous year. Similarly, in 2022, the increase was driven by just a few of the larger adoption services with the other services reporting more or even slightly fewer than the previous year.

Figure 2.8 shows that in 2022, 45% of the children approved for adoption were aged two to five years old and 49% were younger than two years old (infants). This is a return to the pattern observed in the years prior to 2021 (during which there was a reversal where more infants were approved for adoption than two to five years olds).

Timescales to approval

Research has found that it is the early stages of care and permanence planning following a child being accommodated that take the longest time in the overall process⁴.

Once it has been identified that a child should be permanently placed away from home, the adoption and permanence panel decides whether to formally recommend adoption. In the annual return, we ask local authority adoption services about their assessment completion time. This time period begins at the point of the looked after child review agreeing the need for permanence to approval at the adoption panel.

Figure 2.9 below presents the variation in assessment completion time. The numbers represent the number of services. One service completed all assessments within three months (up from zero in the previous year) and eight services took six months or longer to complete all assessments (same as the previous year).

Children and young people approved and placed with families

In 2022, 181 children were placed with their new adoptive family across 26 local authorities (Figure 2.10). This includes children approved for adoption in 2022 and in the previous year/years.

The number of children placed continues to decrease year on year. Not all services report decreases every year, although most of the larger adoption services display a downward trend over the years 2018-2022.

In 2022, 46% of the children placed in households were approved by independent agencies – a proportion that had increased to 61% in 2021 but has returned to a similar proportion observed prior to 2021.

Timescales to match

Adoption and permanence panels find a match for the child in terms of who their long-term carer should be. In the annual return, we ask local authority adoption services about the time it took to match children with adoptive families, from the point of registration at panel to matching at panel.

Figure 2.11 presents the variation in matching time. The numbers represent the number of services and exclude services that carry out registration and matching at the same time. It shows that in two services, it took one year or more to match any children with adoptive families, whilst in three services all matching took less than three months. This does not factor in the quantity of matches, which will vary by service.



Children and young people adopted

In 2022, 193 children and young people were legally adopted. This is up 2% from 189 in 2021, and down 33% from 286 in 2018 (Figure 2.12).

Figure 2.12 The number of children and young people adopted (by court order) each year has levelled off over the last two years compared to the prior downward trend.

This trend is consistent with that published in the <u>Scottish Government's Children's</u> Social Work Statistics 2021-22.

Timescales to adopt

In the annual return, we ask local authority adoption services about the time it took to grant full adoption orders after placing a child with their adoptive family. Figure 2.13 presents the variation in the time taken to grant full adoption. The numbers represent the number of services. It shows that in two services, all cases took a year or more to grant the full adoption order. Zero services granted all orders within six months.

Children and young people awaiting placement

At 31 December 2022, there were 135 children and young people who had been approved for adoption across 25 local authority services and were waiting to be matched with approved adopters (Figure 2.14). This was similar to 134 in 2021 and still in line with the overall downward trend in the number of children approved for adoption.

Of the children waiting to be matched in 2022:

- 56 (41%) were part of a family group that services were trying to keep together (28 family groups in total)
- 21% had been waiting for over one year, down from 38% the previous year.

Services were instructed to count children individually, so for example, two children who are part of a family group were counted as two.

We asked local authority services about the ages of the children and young people who were waiting to be matched.

Figure 2.15 shows that as in previous years, at 31 December 2022 there were children of all ages waiting to be matched with approved adopters, although few services had children aged six and over waiting to be matched.

Adoptions that break down

In 2022, 12 adoptions broke down (disrupted). This is down from 37 in 2021.

Of these breakdowns, the majority (12) happened before the adoption order was granted, with fewer than five occurring after the adoption order was granted. Most of the breakdowns took place in households approved by the local authority that placed the child.

The terms 'broke down' and 'disrupted' are not defined in the annual return and are therefore open to interpretation by the adoption service, which means that what one service counts as a disruption or breakdown may differ from what another service counts.

Other services

Post-adoption support

Local authorities have a duty to provide post-adoption support to families who adopt and to children who are adopted. They also have a duty to provide support and guidance to adult adoptees who wish to obtain their birth records.

All local authority adoption services provided post-adoption support to adoptive households in 2022, ranging from supporting fewer than five to supporting 518 households. In total, 2,430 households received post-adoption support from local authority adoption services, and 659 received post-adoption support from independent services. similar to 2021.

Services outside Scotland

In 2022, there were 39 children and young people placed in adoptive households in Scotland from elsewhere in the UK, and 11 were placed elsewhere in the UK by Scottish local authorities (Figure 2.17). The numbers are low so tend to fluctuate from year to year.

Adoption service evaluation

Based on Care Inspectorate evaluations, the overall quality of adoption services on 31 March 2023 was positive. As Figure 2.18 presents, 82% of adoption services had evaluations of 'good' or better across all key questions.

Between 1 April 2022 and 31 March 2023, we inspected 16 adoption services. Of those 16 services, 81% (13) had evaluations of good or better across all key questions at 31 March 2023.

Summary of adoption

Between 2018 and 2020, the number of children approved for adoption (Figure 2.7) and the number of children legally adopted (Figure 2.12) decreased each year. In the past two reporting years however, the number of legal adoptions has levelled off, and the number of children approved for adoption has increased. In 2022, the age pattern of children approved for adoption reverted to the pre-2021 distribution with more infants approved for adoption compared to children aged two to five years old (Figure 2.8). This means that more children are moving towards permanence at an earlier age.

Children are still experiencing delays in being approved for adoption – with many services reporting a time span of six months or longer from identifying the need for a child to be placed away from home and the adoption panel formally recommending adoption for a child (Figure 2.9). Delays are also evident at the point of matching a child with their adoptive family (many services reporting a time span of six months or longer) and becoming legally adopted (in many cases, this took 12 months or longer) (Figures 2.11 and 2.13). In addition, the data highlights long assessment times for prospective adoptive households (Figure 2.2). These factors combined extend the time it takes for children and young people to be placed permanently with a family.

At the same time, there is a downward trend in the number of children and young people waiting to be matched with adopters (Figure 2.14).

Some of the children waiting to be matched were part of a family group that services were trying to place together, which shows a strong commitment to keeping brothers and sisters together. However, of the new households approved to adopt, 37% (87 households) were approved for family groups of two children and less than 1% (fewer than five households) were approved for family groups of three or more children. There has been an increase since 2018 in the proportion of new households approved to adopt family groups of two children (Figure 2.4). The Promise highlights the importance of brother and sister relationships.

The number of adoptions that break down has fluctuated from year to year over the period 2018-2022 (Figure 2.16). Over the five years covered in this report, there was a peak of 29 breakdowns in 2021, however in 2022, only 12 breakdowns were recorded. This is in parallel with an increase in support given to adoptive families as services recover from the impact of the Covid-19 pandemic during which the number of households that were provided with support was low.

Despite the challenges faced by adoption services, such as staff shortages (see <u>Staff vacancies in care services 2021</u> report) most adoption services are of good quality overall, with 82% of services holding a Care Inspectorate evaluation of good or better across all quality themes/indicators at 31 March 2023 (Figure 2.18).
